

CONTRACT MODIFICATION NO. 05
BETWEEN THE COMMONWEALTH OF VIRGINIA
UNIVERSITY of MARY WASHINGTON and DB INVESTMENT INTERMEDIATE HOLDINGS 2, INC.
DBA CONVERGINT TECHNOLOGIES, LLC
August 22, 2023

In accordance with the terms and conditions of the original Contract, UCPUMW 15-378, "Changes to the Contract", the following modifications have been mutually agreed upon, and will take effect after full execution of this document by both parties.

Relative to the general scope of the above referenced contract, the University of Mary Washington hereby modifies the contract as follows:

Per the terms and conditions of the contract for permitted escalation, CPI-W Table 6 was used to determine a 12-month change of 3.6%. Adequate documentation was provided by Convergent showing across the board price increases in labor rates and materials over the past couple of years. This supported a request in rate increases above the permitted CPI. It is noted that Convergent went several years without imposing increased labor and material rates on the University. If they had, those rates would have surpassed the current rates of this modification. CPI-W Table 6 will be used each year going forward at renewal, upon request by Convergent, for the remainder of this contract. This one-time increase is hereby authorized effective upon full execution of this document through June 30, 2024 as follows:


All other terms and conditions of the original contract referenced above shall remain in force.
