

ASSIGNMENT OF CONTRACT

This Assignment Agreement, made this day February 19, 2025 by and among the University of Mary Washington, an institution of higher education of the Commonwealth of Virginia ("UMW" or "the University"), The Wood Company d/b/a Wood Dining Services, a wholly-owned indirect subsidiary of Sodexo Management, Inc. ("Assignor"), and Sodexo Operations, LLC ("Assignee") in consideration of the mutual covenants herein contained and other good and valuable consideration, the sufficiency of which is hereby acknowledged, witnesseth:

WHEREAS, the University and The Wood Company d/b/a Wood Dining Services, a wholly-owned indirect subsidiary of Sodexo Management, Inc. entered into contract UCPUMW 23-1457 (the "contract") to provide Dining Service Operations for the University of Mary Washington;

WHEREAS, Assignor wishes to assign its rights and obligations under the contract to Assignee;

WHEREAS, Assignee wishes to assume all rights and obligations of Assignor pursuant to the contract; and

WHEREAS, the University wishes to consent to the assignment of the contract from Assignor to Assignee.

NOW THEREFORE, in accordance with Section 3.10, Section 8.1.C, and Section 9.25 of the contract, the parties agree as follows:


1. Effective February 19, 2025, Assignor and Assignee hereby agree that the Assignor shall assign all rights, title, and interest, and delegate all obligations, responsibilities, and duties, pursuant to the contract, to the Assignee.
2. Effective February 19, 2025, Assignee hereby accepts the assignment of all Assignors obligations, responsibilities, and duties under the contract, and all of the Assignor's rights, titles, and interests pursuant to the contract.
3. The University consents to the assignment of the contract(s) to the Assignee as provided in this assignment.
4. Assignor shall continue to be responsible, pursuant to the terms of the contract, for all claims under the contract arising before February 19, 2025.
5. The contract shall remain in full force and effect without modification except as mutually agreed upon by both parties in accordance with the terms in the original contract.
