



CONTRACT MODIFICATION NO. 03
BETWEEN THE COMMONWEALTH OF VIRGINIA,
UNIVERSITY of MARY WASHINGTON and SODEXO OPERATIONS, LLC
June 23, 2025

In accordance with the terms and conditions of the original contract, UCPUMW 23-1457, "Changes to the Contract", ARTICLE IX, 9.5, the following modifications have been mutually agreed upon, and effective May 19, 2025.

Referencing ARTICLE IV, 4.2.B, Summer Meal Plans, summer residential students are required to purchase one (1) of the following summer meal plans:

50 Block Summer	50 meals per summer session

Referencing ARTICLE VII, 7.2.B, Summer Meal Plan Rates, the following resident dining rates shall be in effect for the summer of 2025 and summer of 2026:

30 Block Summer (no flex)	\$10.38	3.00%
50 Block Summer (no flex)	\$14.61	3.00%
15 Block Summer (no flex, off-campus only)	\$5.19	3.00%
