



CONTRACT MODIFICATION NO. 04
BETWEEN THE COMMONWEALTH OF VIRGINIA,
UNIVERSITY of MARY WASHINGTON and SODEXO OPERATIONS, LLC
August 12, 2026

In accordance with the terms and conditions of the original contract, UCPUMW 23-1457, "Changes to the Contract", ARTICLE IX, 9.5, the following modifications have been mutually agreed upon, and become effective August 1, 2026.

Referencing UMW Contract Modification No. 02, section 2.16, "Vending Service" and Section 4.3, Subsection D, "Just Baked Vending Service":

- a. The "Just Baked Vending Service" currently located and operating in Eagle Landing shall be replaced by the Contractor with one (1) frozen and one (1) ambient "Byte Locker" (equipment).
- b. Contractor shall also provide and install into operation at the UMW Apartments one (1) frozen Byte Locker and one (1) ambient Byte Locker (equipment).

Referencing ARTICLE VII, 7.2.A., Dining Rates: the following Meal Plan options and rates shall be in effect for the 2026-2027 Academic Year:

Referencing ARTICLE VII, 7.2.B., Summer Meal Plan Rates: the following resident dining rates shall be in effect for the summer of 2027:

15 Block Summer (no flex, off campus only)	\$5.34	3.0%

Referencing Contract ARTICLE VII, 7.2 D., Guest Meals in Resident Dining Facilities: Prices for guest meals purchased in resident dining facilities shall be as follows, plus tax for cash and EagleOne purchases:

The door rate for Faculty and Staff shall be \$7.80 (price inclusive of state and local taxes) for each meal, breakfast, lunch, and dinner.
