



CONTRACT MODIFICATION NO. 15
BETWEEN THE COMMONWEALTH OF VIRGINIA,
UNIVERSITY of MARY WASHINGTON and THE WOOD COMPANY,
a Pennsylvania corporation and wholly-owned
indirect subsidiary of SODEXO MANAGEMENT, INC.
January 18, 2019

In accordance with the terms and conditions of the original Contract, 12-06, "Changes to the Contract" under the University's Mandatory General Terms and Conditions, the following changes have been mutually agreed upon, and will take effect after full execution of this document by both parties.

Relative to the general scope of the above referenced contract, the University of Mary Washington hereby modifies the contract as follows:

Referencing A.4.a: STUDENT MEAL PLANS/BOARD PLAN PRICES*

**Paragraph below, including numbers 1-3 are referenced in Modification #12.*

** #4 is the only change: removed "including summer" verbiage.*

All residential students are required to subscribe to a meal plan. Upper class students may choose between Eagle Unlimited, 225 block, and 150 block. Senior students with at least 90 credit hours may choose from any residential plan. Eagle Landing and UMW apartment residential students may subscribe to the 75 block plan or greater; commuters may choose between 3, 5, 8, 30, 75 block or greater.

1. Seniors living on campus shall be allowed to select from the following meal plans: Eagle Plan, 225 Block Plan, 150 Block Plan, 90 Block Plan and 75 Block Plan
2. Meal plans shall be available for use on the first day of students returning to campus.
3. For both the 3 Meals per Week Plan and the 5 Meals per Week Plan, unused meals will be forfeited at the end of each week. The dining meal runs from Friday morning to Thursday evening.
4. The following meal plan options with daily rates shall be offered for the 2018-19 (FY19) academic year:
